- 1.Roll Call: Present: Chairman Willems, Treasurer Schultz, Trustee Stahelin, Vice Chairman Mulder, Chief Roman and Members of the Department, and of Oneida Township. Excused Secretary Lantz.
2. Pledge of Allegiance was given.

- 6.Committee and Board Reports:  
Chairman moved to item E. Building Committee, RFQ update. Chief Roman said there were four firms who had submitted a proposal and they would be interviewed on Thursday March 20th by the Building Committee and two Residents, one from the City, Todd Gout and one from the Township, Keith Weaver. Chairman Willems thought it was a good idea to have the public involved.

Chief asked to move back to item C. Public Education: He had been in Lansing working with the Teachers on the Roman Kits and also with the Grand Ledge Schools working on training with the kits. He was proud of the schools and the work they were doing.

7. Fire Chief and Staff Reports:

Chief Noted that the total EMS Runs for February were 243 the highest in the past year. Chief said there is more Mutual aid given by the Department than taken., EMS: total runs 243, City 163, Twp. 28,

Rosand 8, Mutual Aid 44. Fire Total 100, City 70, Twp. 17, Mutual Aid 13.

funds to good use. Mr. Mulder echoed Mr. Staheli's  
comments, and thanked the Chief for his efforts.

Mr. Mulder discussed what the DDA had given back  
to GLEASE in the past, the ladder truck and said he  
felt confident that the DDA would assist GLEASA by  
giving funds back. He also wanted the Township to

give to GLEASA. Which Mrs. Schultz said she was sure they would, but the Township doesn't have the ability to take back funds it has already paid like the City.

Mr. Weaver questioned the number of runs to Roxand and if they could participate in an updated contract. Chairman Willems noted that there is a group forming against the Eaton County Millage that will be on the ballot this May. He noted that the city, the Township and GLEASA all have to work together to support the projects we have been discussing.
